
TRUST DEED

WHERE AS THE FOUNDER is desirous of establishing a irrevocable trust with a view to provide health, environment, literacy rural development and human resource development and to run social service projects to serve the poor and needy and to promote and Develop the socially, educationally and economically downtrodden people of India more fully described under the objects clause.

WHEREAS prior to the execution of these presents the Founder has handed over to the Trustees a sum of Rs.1,000/- (Rupees One Thousand only) and the receipt of which sum the Trustees do hereby admit to be held by them in just together with further donations and contributions and any property that may thereafter be transferred to the trust.







III. OBJECTS :

The objects for which the trust is established which are NOT FOR THE PURPOSE OF PROFIT but for public charitable, socio-economical, cultural, medical and educational purpose which shall not be restricted to any particular caste, creed, religion or sex and the operation of which is restricted to only the Indian territories are as follows;


1. To conduct Youth Empowerment & Rural development programs.
2. To start and organize non-formal education centers, adult education centers, literacy programs etc.,
3. To establish pre-primary schools, Balanandams, crèche centers, mentally retorted schools, and school for physically handicapped children.
4. To establish libraries and reading rooms, community halls and sports & games centers.
5. To improve education standards and education infrastructure.
6. To promote good citizenship, particularity among youth and children.




7. To start homes for old age people, handicapped, mentally handicapped, Duff & dumb, Blind and widows.
8. To conduct Agriculture development, farmers awareness programs.
9. To conduct environmental, greenery programs.
10. To conduct water conservation and sanitary programs.
11. To conduct women and child welfare programs.
12. To help HIV, AIDS People and conduct awareness programs.
13. To Support people in natural calamities.
14. To provide help and rehabilitation for the needy masses affected by natural calamities like flood, drought, cyclone and other emergencies.
15. To promote facilities for the social, economical and moral well being of the destitute, widows, and orphans.
16. To provide safe drinking water and sanitation of rural areas.
17. To generate health and environmental awareness and to establish concept confederation of organizations of nutrition, consumer education, environment protection and trust.
18. To establish working women hostel, short stay homes.
19. To establish Temples and Devotional Mandirs.
20. To promote Short Films, Documentary and Cultural programmes.
21. To develop awareness and methods of environment protection and pollution control.
22. To establish Schools and Colleges, Cultural Institutions, Clinics, Hospitals and Health Centers, to provide ambulance services and to conduct monthly health camps and blood bank and eye bank to provide all possible medical help to all specially to economically backward, poor and needy.
23. To facilitate the deprived and under privileged youth towards their opportunities and rights and cultural exchange for a global peace.
24. To produce and publish literature, to conduct seminars and symposiums and to carry on social engineering projects and economic oriented projects.
25. To conduct awareness for Child Labor, Child Rights, Child Atrocities.
26. To do all such other lawful things that are necessary and conducive to promote, further and attainment of the above objects of the Trust either individually by itself or in association and partnership with other Voluntary Agencies having similar objects. The objects incidental or ancillary for the attainment of the above objects are :

- a. To publish magazines, journals, periodicals, pamphlets, books, booklets etc., for distribution to bring about social, moral and cultural awareness.
- b. To conduct research and to establish research institute and training for the promotion of the objectives of the Trust. Begin with ideas.
- c. To conduct cultural, fine arts, sports, educational and vocational competitions, seminars exhibitions and workshops for the talents in their respective fields.
- d. To submit views or make representation before authorities, committees, commission or other bodies including the general public on any subject affecting the interests of the people and to promote or assist the promotion of any legislation or regulation which may appear to be in the interest of the Trust in accordance with and the furtherance of its objects.
- e. To Purchase, take on lease and license, or by way of mortgage or in exchange or otherwise, acquire or hold any movable or immovable property rights, privileges, and to improve and develop any or all of them as may be deemed necessary or convenient for any of the objectives of the Trust.
- f. To invest the funds of the Trust in such manner as may from time to time be determined by the Managing Trustee subject to the modes specified under the provisions of Section 13(1) (d) read with Section 11(5) of the Income Tax Act, 1961., 35(I & II).
- g. To negotiate and enter into any arrangements with other persons, bodies, government, municipal or local authorities that may seem necessary incidental, ancillary, convenient or conducive all or any of the objective of the Trust.
- h. To enter into such contracts or agreements as the Trust may think fit for the purpose of the Trust and for such or any of these purpose, to retain or to employ from time to time skilled professional, technical, commercial or other advisers, whether members of the trust or not, and to pay for their services such fees or remuneration or such proportion thereof as the trust its discretion considers expedient.
- i. To appoint any person or persons whether Members of the Trust or not, that may be required for the purpose of carrying out the objectives and functions of the Trust and to render to them such fee, traveling allowances, accommodations, expenses, sitting fee or such proportion thereof as the Trust in its discretion considers expedient.
- j. To borrow any monies required for the purposes of the Trust upon such terms and upon such securities as may be determined by the Trust.

- k. To accept, hold or administer any gifts, grants, donations, contributions, in kind or money, whether upon Trust or otherwise, and to undertake or execute any Trust or obligation which may be deemed conducive to any of the objectives of the trust, and in this connection to issue appeals and applications for money and funds.
- l. To contribute, donate, give, aid pecuniary or otherwise to any person, association, body and / or movement, in keeping with the objects of the Trust.
- m. To assign, mortgage, lease, exchange or otherwise transfer or dispose off, turn into account or otherwise deal with all or any properties movable or immovable of the Trust as may be necessary or convenient for the working of the Trust with the permission of the Chairman or the Board of Trustees.
- n. It is here by declared that no benefit shall be passed on either directly or indirectly to the Trustees of the Trust.

To do all such other acts, deeds and things, as the trust may consider incidental or conducive to the attainment of the objects of the Trust, viz for "Bright tomorrow", towards.

IV. FUNCTIONS OF THE TRUSTEES :
FOUNDER & CHAIRMAN:


The CHAIRMAN of the Trust shall be the Head of the Trust. Either in the case of voluntary resignation or in case of his demise of the Chairman, Managing Trustee Shall take over as the CHAIRMAN of the trust with effect from the date of such resignation or demise until to elect the new CHAIRMAN.

The CHAIRMAN of the Trust shall be the Chief Executive of the Trust. He shall be the Chief Functionary of the Trust and shall represent the trust in relation to all matters connected with the Trust. He shall also be authorized to look after the day-to-day operations of the Trust. He shall call for the meetings and shall maintain the minutes of the meeting of the Trustees. He shall operate bank account behalf of trust jointly with Trustee – Treasurer. He/She shall be responsible for maintaining the accounts, preparing the budgets, for getting the accounts audited and to submit the same in the meeting of the Trustees. He/She shall be authorized to enter into all agreements and contracts in the name of the Trust and such agreements and contracts will have binding on the Trust. The Chairman have casting vote.

The CHAIRMAN is authorized to nominate new trustees or terminate services of a trustee on the board of Trustees. He may be advised by the board of Trustees.

TRUSTEE-TREASURER:

He/She is the responsible person of the financial transactions relating to the Trust. He/She has to maintain accounts properly along with the vouchers. He/She has to prepare the budget expenditure statement of the society with the guidance of CHAIRMAN. He/She shall operate bank account behalf of trust jointly with Founder & Chairman.



TRUSTEE :

He / She shall co-operate with board of Trustees in all Trust activities. One of the Trustees may be appointed as managing trustee by the Chairman to act on his/her behalf in his/her absence.

V. FUNDS OF THE TRUST :

The funds of the Trust shall be invested in the manner specified under the provisions of Sec.13(1) (d) read with Sec.11(5) or such other provisions hereafter formulated of the

Income Tax Act, 1961. The funds and the income of the trust shall be wholly utilized towards the objects of the trust and no portion of the Trust Fund shall be utilized for payment to the trustees by way of profit, or interest or dividend or other wise and no Trust fund shall be earmarked for the purpose of making provision for a dependent of a diseased or a disabled Trustee.

VI. BANK ACCOUNTS :

The Bank Accounts shall be opened in any Scheduled Bank, the account therein shall be in the name of the Trust and the same shall be operated by Founder & Chairman and Trustee -Treasurer.

The Trust shall also have all rights to borrow loans from Banks or other financial institutions either on mortgage or pledge or otherwise for the purpose of achieving the objects of the Trust and all the documents for the same shall be executed by the Trust.

VII. ACCOUNTS & AUDIT:

The accounting year of the trust shall be the financial year i.e. from 1st day of April to 31st day of March. The CHAIRMAN shall arrange for the maintenance of correct and proper accounts of the receipts, payments, liabilities incurred and assets acquired. All the accounts of the Trust shall be duly audited with all necessary vouchers at least once in every year by a CHARTERED ACCOUNTANT (Explanation to Sec. 288 (2) of the Income Tax Act, 1961)

VIII. MEETING OF THE TRUSTEES :


There shall be an annual meeting of the Trustees when the annual audited statements of the accounts shall be considered and adopted. The CHAIRMAN shall, at such meeting, place before the Trust a report on the working of the Trust and its projects. Seven days notice shall be given for meeting of the Trust.

The annual meeting of the TRUST shall be held at the registered office of the Trust or at any other office of the institutions run under the Management of Trust. In case the Trustees are equally, divided, the Chairman shall have a casting vote. In case of urgency, decisions can be taken by circular vote which shall be rectified at the next regular meeting.

The quorum for a general body meeting of the Trust shall be FOUR TRUSTTES or 2/3rd of the total TRUSTEES whichever is higher. In the absence of the CHAIRMAN any Managing Trustee shall do the functions of the CHAIRMAN for the day.

IX. TRUSTEES AS STAFF :

The Trustees of the Trust may also be appointed to staff positions in the programmes of the Trust and the TRUSTEES of the Trust are not entitled to any remuneration out of the funds of the Trust except travel on Trust work and accommodation expense and sitting



allowance for the days of the meeting. This provision shall not apply to the TRUSTEES of the Trust serving as full time staff of the Trust and its programmes, wherein such fulltime trustees shall be eligible for remuneration.

X. RULES OF INCOME TAX ACT 1961 :

1. The income of Trust shall be applied for charitable purposes in INDIA only.
2. The name of the Trust hereby made shall not be REVOCABLE.
3. The funds of the Trust shall be invested in the modes of specified under the provision of sec. 13(1)(D) read with sec. 11(5) of the Income Tax act. 1961 as amended from time to time.
4. The accounts of the Trust shall be maintained regularly. The accounts shall be audited by chartered accountant every year and the account will be closed by 31st March every year.
5. In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed among the members of the Board of Trustees but the same shall be transferred to another Trust whose objects are similar to those of this Trust and registered with the commissioner of income tax U/S section 12 A & 80 G of the Income Tax act. 1961.
6. No amendments to the memorandum of association and rules and regulation shall be made without the prior permission commissioner of Income Tax.
7. The objects of the Trust are open to all irrespective of caste, creed, religion & sex.
8. The Funds of the Trust shall be solely utilized for the furtherance of the objects of the Trust and no part of it shall be distributed among the trustees of the Trust by way of profit or dividend or otherwise.

XI. AMENDMENTS:


The trustees may from time to time formulate and alter the rules and regulations for the proper conduct of the trust and its objects by recording the same in Minutes. The quorum of meetings of the Trusts where amendments to the constitution of the Trust are made shall be 2/3rd of the trust or 7 whichever is higher.

XII. AUTHORITY TO SUE AND TO GIVE DIRECTIONS :

The Founder & Chairman of the Trust shall be authorized to sue or to be sued on behalf of the Trust and he shall be empowered to give directions with regard to the Management of the Trust.

XIII. DISSOLUTION :

The Trust can be dissolved or wound up by 2/3rd majority decision of Trustees at an Trust Meeting of the TRUSTEES and the Assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees of the Trust but the same shall be transferred to another charitable Trust whose objects are similar to those of this Trust and which is charitable nature and registered under section 12 A (a) of Income Tax Act.




